ABERDEEN INVESTMENT FUNDS ICVC (TO RENAMED ABERDEEN STANDARD OEIC I) CHANGES TO ABERDEEN UK MID-CAP EQUITY FUND (TO BE RENAMED ASI UK MID-CAP EQUITY FUND) INVESTMENT OBJECTIVE AND POLICY

Please read this letter carefully as it contains important information regarding upcoming changes to the above fund.

Please note that these changes are in addition to the following changes we are making to all UK funds and which we will write to you about separately:

- **Change of Name; and/or**
- **Disclosure of Benchmark; and/or**
- **Revision of Investment Objectives and Policy wording**

In this letter, when we say 'we' or 'us', we mean Aberdeen Standard Fund Managers Limited – the company that is currently responsible for managing and operating your investment in the Aberdeen UK Mid-Cap Equity Fund (the "**Fund**").

We are writing to you let you know about some changes to the Fund. The Financial Conduct Authority (the "**FCA**"), which regulates both us and the UK funds we manage (the "**UK Funds**"), has made some changes to its rules which we, and the UK Funds, need to comply with by **7 August 2019**. We will send a separate letter to you on or around the date of this letter, which sets out and explains these changes.

We also wanted to let you know that we have taken the opportunity to make some other amendments to the investment policy of the Fund. The purpose of this letter is to explain these additional changes. **You don't need to take any action in response to this letter**; but we would encourage you to familiarise yourself with the changes.

Changes to the Fund

Investment objective and policy

We have decided that it is in the best interests of our investors to amend the investment policy of the Fund to slightly widen the definition of a mid-capitalisation stock. Currently a mid-capitalisation stock is defined as any stock that is a constituent of the FTSE 250 excluding Investment Trusts Index ("**Index**"). This will be amended to define mid-capitalisation stock as stock included in the Index or, if not included within the Index, any stock having a market capitalisation that would otherwise make it eligible for inclusion within the Index. This will allow the Fund to hold mid-capitalisation stocks that are not listed as part of the Index. We have also decided to reduce the minimum amount that needs to be held in mid-capitalisation stocks from 80% of the Fund to 60%. This will allow the Fund to continue to hold mid-capitalisation stock as they grow larger and to hold a slightly larger element in smaller capitalisation stocks. These changes combined will not materially change the risk profile of the Fund.

With effect from **7 August 2019** we will also update the Prospectus and the Key Investor Information documents to better reflect how the Fund will be managed. Please note you may see changes to the Factsheet document produced for the Fund.

All the changes described in this letter will take effect on **7 August 2019**.

Current Investment Objective	New Investment Objective
<p>The Fund's objective is to maximise total return from capital investment predominantly in the companies of the FTSE 250 Index (excluding investment trusts), though other UK listed equities may be held where the ACD deems this appropriate.</p> <p>Note: The term 'total return' means a combination of income and capital growth and no positive return is implied.</p>	<p>Investment Objective: To generate growth over the long term (5 years or more) by investing in UK mid-capitalisation equities (company shares).</p> <p>Performance Target: To achieve the return of the FTSE 250 excluding Investment Trusts Index, plus 3% per annum over three years (before charges).</p> <p>The Performance Target is the level of performance that the management team hopes to achieve for the fund. There is however no certainty or promise that they will achieve the Performance Target.</p> <p>The ACD believes this is an appropriate target for the fund based on the investment policy of the fund and the constituents of the index.</p>

	<p>Portfolio Securities</p> <ul style="list-style-type: none"> • The fund will invest at least 60% in mid-capitalisation equities and equity related securities of companies listed, incorporated or domiciled in the UK or companies that derive a significant proportion of their revenues or profits from UK operations or have a significant proportion of their assets there. • Mid-capitalisation companies are defined as any stock included in the FTSE 250 excluding Investment Trusts Index or, if not included within the index, any stock having a market capitalisation smaller than that of the stock with the largest market capitalisation in such index. • The fund may also invest in smaller and larger capitalisation companies listed, incorporated or domiciled in the UK. • The fund may also invest in other funds (including those managed by Aberdeen Standard Investments), money-market instruments, and cash. <p>Management Process</p> <ul style="list-style-type: none"> • The management team use their discretion (active management) to maintain a diverse asset mix at sector and stock level.

- Their primary focus is on stock selection using the management team's quality, growth and momentum approach. It aims to identify companies that show a range of high quality characteristics, operate in growing markets and display positive business momentum.
- In seeking to achieve the Performance Target, the FTSE 250 ex Investment Trusts Index is used as a reference point for portfolio construction and as a basis for setting risk constraints. The expected variation ("tracking error") between the returns of the fund and the index, is not ordinarily expected to exceed 9%. Due to the active nature of the management process, the fund's performance profile may deviate significantly from that of the index.

Derivatives and Techniques

- The fund may use derivatives to reduce risk, reduce cost and/or generate additional income or growth consistent with the risk profile of the fund (often referred to as "Efficient Portfolio Management"). Derivative usage in the fund is expected to be very limited. Where derivatives are used, this would mainly be in response to significant inflows into the fund so that in these instances, cash can be invested while maintaining the fund's existing allocations to company shares.
