**Emerging Market Debt Sustainable and Responsible Investment Fund, a US Dollar denominated sub fund of the Standard Life Investments Global SICAV II, Class A Accumulation Shares (ISIN:LU1966671726). This share class is hedged to Euro and the price is expressed in Euro. Aberdeen Standard Investments Luxembourg S.A. is the Management Company.**

Objectives and Investment Policy

The fund aims to generate income and growth over the long term by investing in bonds.

It will seek to achieve this objective primarily through investment in US Dollar denominated interest bearing securities including sovereign and supranational issued bonds as well as sub-investment grade bonds, all issued by Asian, Eastern European, Middle Eastern, African or Latin American countries. All Sovereign and Supranational bonds will meet our internal sustainable and responsible criteria with a screening process which has been designed to incorporate Environment, Social, Governance and Political factors. In addition, the fund may hold sovereign bonds and other bonds issued in non-emerging market countries around the world that meet this criteria, as well as derivative instruments. The fund may also invest in funds (including those managed by Aberdeen Standard Investments) and money-market instruments including cash on an ancillary basis. The fund is actively managed by the investment team who seek to take advantage of opportunities they have identified through direct investment or derivatives. The fund's holdings will typically consist of individual bonds but derivatives (including bond futures, interest rate, inflation and credit

default swaps as well as currency forwards) may be used to gain or reduce (hedge) exposure and seek investment gains.

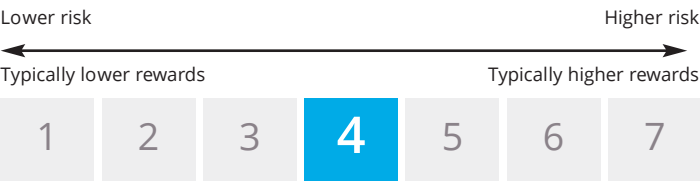
The fund will routinely use derivatives to reduce risk or cost, or to generate additional capital or income at proportionate risk (Efficient Portfolio Management) or to meet its investment objective. Derivatives may be used to provide market exposures different to those that could be achieved through investment in assets in which the fund is primarily invested. Usage of derivatives is monitored to ensure that the fund is not exposed to excessive or unintended risks.

Any income, for example interest income, received by the fund will be reinvested.

Investors in the fund may buy and sell shares on any normal business day.

Recommendation: the fund may not be appropriate for investors who plan to withdraw their money within five years. Investors should satisfy themselves that their attitude to risk aligns with the risk profile of this fund before investing.

Risk and Reward Profile



This indicator reflects the volatility of the fund's share price over the last five years which in turn reflects the volatility of the underlying assets in which the fund invests. Historical data may not be a reliable indication for the future.

As the share class does not have a history of five years, an alternative share class, a comparable fund or a representative benchmark has been used to show how the share class price may have behaved over the period.

The fund is rated as {4} because of the extent to which the following risk factors apply:

- (a) The fund invests in securities which are subject to the risk that the issuer may default on interest or capital payments.
- (b) The use of derivatives carries the risk of reduced liquidity, substantial loss and increased volatility in adverse market conditions, such as a failure amongst market participants. The use of derivatives may result in the fund being leveraged (where market exposure and thus the potential for loss by the fund exceeds the amount it has invested) and in these market conditions the effect of leverage will be to magnify losses.
- (c) The fund invests in emerging market equities and / or bonds. Investing in emerging markets involves a greater risk of loss than investing in more developed markets due to, among other factors, greater political, tax, economic, foreign exchange, liquidity and regulatory risks.
- (d) The fund invests in high yielding bonds which carry a greater risk of default

than those with lower yields.

(e) The fund price can go up or down daily for a variety of reasons including changes in interest rates, inflation expectations or the perceived credit quality of individual countries or securities.

The fund employs a single swinging pricing methodology to protect against the dilution impact of transaction costs. A change in the pricing basis will result in movement in the fund's published price.
