Accordingly, you may deduct your portion of the taxes in computing your taxable income. Alternatively, it may be beneficial for you to forego the deduction and to take a credit against your tax liability. These deductions or credits may be subject to limitations under the tax law. Your portion of the foreign taxes paid has been included on your Form 1099-DIV.
