	e terms of reference are drafted in accordance with the UK Corporate Governance Code, issued in
July 2	2018.
1.	Membership
1.1	The Committee shall comprise at least two directors. A majority of the members of the Committee
1.1	shall be independent non-executive directors.
1.2	Only members of the Committee have the right to attend Committee meetings. However, other
	individuals such as representatives of the Manager may be invited to attend for all or part of any
	meeting, as and when appropriate and necessary.
1.3	The Board shall appoint the Committee Chairman who should be either the Chairman of the Board
	or an independent non-executive director. In the absence of the Committee Chairman and/or an
	appointed deputy, the remaining members present shall elect one of themselves to chair the
	meeting from those who would qualify under these terms of reference to be appointed to that
	position by the Board. The Chairman of the Board shall not chair the Committee when it is dealing with the matter of succession to the Chairmanship.
2.	Secretary
	Company Secretary of the Board, or his or her nominee, shall act as the Secretary of the Committee.
3	Quorum
	quorum necessary for the transaction of business shall be two, both of whom must be independent
	executive directors. A duly convened meeting of the Committee at which a quorum is present shall be
	betent to exercise all or any of the authorities, powers and discretions vested in or exercisable by the mittee.

4.	Frequency of meetings
	Committee shall meet at least once in a year and otherwise as required.
5.	Notice of meetings
5.1	Meetings of the Committee shall be called by the Secretary of the Committee at the request of the
	Committee Chairman
5.2	Unless otherwise agreed, notice of each meeting confirming the venue, time and date, together with
	an agenda of items to be discussed, shall be forwarded to each member of the Committee, any
	other person required to attend and all other non-executive Directors, no later than five working
	days before the date of the meeting. Supporting papers shall be sent to Committee members and to other attendees as appropriate, at the same time.
6.	Minutes of meetings
6.1	The Secretary shall minute the proceedings and resolutions of all Committee meetings, including
	the names of those present and in attendance.
6.2	Draft minutes of Committee meetings shall be circulated promptly to all members of the Committee.
	Once approved, minutes should be circulated to all other members of the Board unless it would be
	inappropriate to do so.
7	Annual Conorol Mosting
7.	Annual General Meeting Committee Chairman should attend the Annual General Meeting to answer any shareholder questions
	e Committee's activities.
8.	Duties
	Committee should carry out the duties below.
	Committee shall:
8.1	regularly review the structure, size and composition (including the skills, knowledge, experience and
	diversity) of the Board and make recommendations to the Board with regard to any changes.

8.2	give full consideration to succession planning for Directors in the course of its work, taking into account the challenges and opportunities facing the Company, and the skills and expertise needed on the Board in the future.
8.3	keep under review the leadership needs of the organisation with a view to ensuring the continued ability of the organisation to compete effectively in the marketplace.
8.4	keep up to date and fully informed about strategic issues and commercial changes affecting the Company and the market in which it operates.
8.5	be responsible for identifying and nominating for the approval of the Board, candidates to fill Board vacancies as and when they arise.
8.6	before any appointment is made by the Board, evaluate the balance of skills, knowledge,
0.0	experience and diversity on the Board and, in the light of this evaluation, prepare a description of the role and capabilities required for a particular appointment.
	In identifying suitable candidates the Committee shall:
	8.6.1 consider open advertising or the services of external advisers to facilitate the search.
	8.6.2 consider candidates from a suitably wide range of backgrounds.
	8.6.3 consider candidates on merit and against objective criteria and with due regard for the benefits of diversity on the Board, taking care that appointees have enough time available to devote to the position.
8.7	for the appointment of a Director, the Committee should prepare a job specification, including the time commitment expected. A proposed Director's other significant commitments, including the time involved, should be disclosed to the Board before appointment.
8.8	prior to the appointment of a Director, the proposed appointee should be required to disclose any other business interests that may result in a conflict of interest and be required to report any future business interests that could result in a conflict of interest.
8.9	ensure that on appointment to the Board, Directors receive a formal letter of appointment setting out clearly what is expected of them in terms of time commitment, Committee service and involvement outside Board meetings.
8.10	determine the format of the Board evaluation process, including the evaluation of the committees of the Board, the Chairman and individual Directors, and give consideration as to whether the process
	should be facilitated by an external evaluator.
8.11	review the results of the Board performance evaluation process that relate to the composition of the Board.
8.12	review annually the time required from Directors. Performance evaluation should be used to assess
0.12	whether the non-executive directors are spending enough time to fulfil their duties.
8.13	review annually the Directors' Remuneration Policy and the level of Directors' fees, including the Chairman.
8.14	consider the need to appoint external remuneration consultants.
	The Committee shall also make recommendations to the Board concerning:
8.15	formulating plans for succession including, in particular, the role of Chairman
8.16	suitable candidates for the role of Senior Independent Director
8.17	membership of the Audit Committee, the Management Engagement Committee, and any other Board Committee, in consultation with the chairman of each of those Committees as appropriate
8.18	the re-appointment of any Director having given due regard to their performance and ability to continue to contribute to the Board in the light of the knowledge, skills and experience required
8.19	the re-election by shareholders of Directors under the annual re-election provisions of the Code or the retirement by rotation provisions in the Company's articles of association, having due regard to their performance and ability to continue to contribute to the Board in the light of the knowledge, skills and experience required and the need for progressive refreshing of the Board (particularly in relation to directors being re-elected for a term beyond six years)
8.20	any matters relating to the continuation in office of any Director
8.21	the level of Directors' fees, further to an annual review
8.22	the assessment of which Directors were considered to be independent and non-independent.
9.	Reporting Responsibilities
9.1	The Committee Chairman shall report to the Board on its proceedings after each meeting on all matters within its duties and responsibilities.
9.2	The Committee shall make whatever recommendations to the Board it deems appropriate on any area within its remit where action or improvement is needed.
9.3	<ul> <li>The Committee shall produce a report to be included in the Company's Annual Report about its activities, which should include the following:</li> <li>the process used in relation to appointments, its approach to succession planning and how both support developing a diverse pipeline;</li> </ul>

	<ul> <li>how the Board evaluation has been conducted, the nature and extent of an external evaluator's contact with the Board and individual Directors, the outcomes and actions taken, and how it has or will influence Board composition;</li> <li>the policy on diversity and inclusion, its objectives and linkage to company strategy, how it has been implemented and progress on achieving the objectives; and</li> <li>the gender balance of the Board.</li> <li>changes to the remuneration policy or the level of Directors' fees</li> </ul>
10.	Other Matters
	The Committee shall:
10.1	have access to sufficient resources in order to carry out its duties, including access to the Company secretariat for assistance as required
10.2	be provided with appropriate and timely training, both in the form of an induction programme for new members and on an ongoing basis for all members
10.3	give due consideration to laws and regulations, the provisions of the Code and the requirements of the FCA' Listing, Prospectus and Disclosure, Guidance and Transparency Rules and any other applicable Rules, as appropriate
10.4	arrange for periodic reviews of its own performance and, at least annually, review its constitution and terms of reference to ensure it is operating at maximum effectiveness and recommend any changes it considers necessary to the Board for approval.
11.	Authority
	committee is authorised by the Board to obtain, at the Company's expense, outside legal or other sional advice on any matters within its terms of reference.
